2011 State Issues Seminar

The **State Issue Seminar (8 hrs.)** is WVPAA's last seminar for 2011 and will be held on December 6th at the Charleston Marriott in Charleston WV. **beginning at 8:30 a.m.** The registration fee will be **\$110 for members** and **\$125 for non-members.**

The **West Virginia Tax Department** will present 3 hours of CPE as one of the sessions. One area will be on **Tax Law Changes for 2011** which will include a discussion of the **2010/2011 Administrative Decisions and Administrative Notices** .

Another subject area will be on **consumer sales and use tax updating changes in 2011.** There will also be **personal income tax and business income tax tips** as a part of this area.

My Taxes, a part of the **Tax Modernization Project**, will be reviewed and updated. **E-filing and related subjects** will also be a part of this subject area.

The **Department of Health and Human Resources** will discuss the

2012 New Hire Reporting requirements. Your clients need to be aware of the new requirement and the legal ramifications if they fail to properly report to the Department Health and Human Resources.

Have you wondered about the **value of an accounting practice?** If you want to buy or sell a practice, what can you expect to receive or pay? How does an accountant prepare for **business secession of his firm?** One of the programs will be on this very subject.

Becoming familiar with the Secretary of State's office and their website can be **extremely** useful to an accountant. There are a number of **little-known uses** that can make an accountant's job easier and broaden one's knowledge about a business or organization. The Secretary of State's office will review the requirements for **business licensing** and **annual reports** as well as political action committee financial reports if an accountant should become active in a political campaign **and much, much more.**

This is a strong 8 hour program with sessions on issues that are hard to find elsewhere. Do plan to attend. Register early so that materials can be prepared.
